

Dear Dance Family,

The 2024-2025 schedule includes new classes, new teachers and new performance companies. This is CACD's twenty third year in business, and we are growing and excelling in every aspect of dance education each year.

Please note that the ages are intended as a guideline for placement. I am happy to assist in finding the most appropriate level for your child.

All registration fees and the first tuition installment is due by September 1st in order to determine appropriate class size. **Class size is limited and will close when full. Classes begin Monday, September 9th.**

Registration fee is \$35 per student. The per student tuition for the year is as follows:

One hour weekly: \$900 \$90 per month

One and a half hours weekly: \$1250 \$125 per month

Two hours weekly: \$1650 \$165 per month

Three hours weekly: \$2500 \$250 per month

Base Company Tuition:

Juniorette Company: \$235/monthly

Junior Company : \$285/monthly

Intermediate Company: \$285/ monthly

Advanced Intermediate Company: \$285/monthly

Senior Company: \$285/monthly

MASTER CLASS SERIES

During the Fall of 2024, the Master Class Series will be integrated into the company program for the Intermediate through Senior Companies. This series will highlight 3 guest teachers/choreographers from the professional dance world. This series is a part of the dance curriculum for the Intermediate through Senior Companies and attendance is required. Information will be sent to all company families, along with the promotional material of the guest artist.

Tuition is based on the months of September through June. **It is not a per class fee structure. Tuition is due the first of each month.** Tuition may be paid in full, quarterly or monthly. There are no refunds for missed classes. Tuition received after the 10th of the month will be charged a \$35 late fee. Returned checks will have a \$35 fee charged to the students account. Checks may be mailed or dropped in the locked slotted mailbox outside of the studio entrance. Cash and Venmo payments are also accepted.

DRESS CODE:

For all company classes, the following dress code is required:

BALLET: Pink tights, pink ballet slippers, black leotard , black ballet skirt optional. No shorts. Hair in bun.

COMPANY CLASS: Black dance wear. Black leotards, tights, shorts, leggings, etc. **HAIR** must always be tied back away from face.

BALLET IS REQUIRED OF ALL COMPANY DANCERS

JAZZ COMPANIES : Black dance wear. Hair off face. Jazz shoes.

ATTENDANCE: Multiple absences will jeopardize company placement. The group as a whole is negatively impacted, in addition to the individual dancer.

DRESS CODE:

RECREATIONAL DANCE

BALLET: Pink tights, pink ballet slippers, leotard. Hair must be tied back and away from face.

JAZZ: Leotard and tights/jazz pants or leggings. Jazz shoes. Hair back

HIP HOP: Black Vans, dance wear, hair off face. Please note that the sneakers must be indoor use ONLY. Not worn outside.

TAP: Leotard and tights. Tap Shoes. Hair back.
